FEES & CLASS SIZE

Our minimum class size of 10 paying students will continue insuring classes are made in local areas.

COURSE REGISTRATION PROCESS

1. Pre-registration is mandatory to obtain course location information, etc. Class size ranges from 10-20 students.
2. Complete the registration form or register through the IIED Website www.iied.net. Complete one form per student. Duplicate the form as needed.
3. Submit registration form and payment. Remember full payment must be received 10 business days before course begins to qualify for Early Registration Fee. **Only a check, credit card or online payment qualifies as full payment for Early Registration Fee. Purchase Orders do not qualify as full payment.....**
4. Upon receipt of registration form and fee, IIED will forward course location and hotel information. If requested, course manuals can sent in advance of the class for mailing and handling charges.
5. Course Completion Certificate or notification to TCEQ of course completion will not be issued until full payment of course fee is received. This action may delay License Issuance.

6. If registered student is unable to attend class.
 - No charge if cancellation or course transfer is completed 10 calendar days before start of the course.
 - 70% fee refund if attendance is cancelled less than 10 calendar days before course begins.
 - A \$40.00 transfer fee if course transfer is made within 10 calendar days before course begins.

Remember full Early Registration payment must be received 10 business days before course begins, including payment of purchase orders.

COURSE CANCELLATION

A course may be cancelled if a minimum of 10 students have not registered ten (10) calendar days prior to the start date of the class. All registered students will be notified and allowed to transfer to another course at no charge or receive a full refund of the fee paid.

OTHER COURSES OFFERED

TRANSFER STATION

16 hour course covers the basic technology and operations of a MSW transfer station.

SAFETY

16 hour course in safety planning and practices as part of daily operations.

COLLECTION SYSTEM ANALYSIS

8 hour site specific course training in performing a 6 step analysis of the collection system.
